- My husband was supervisor for many years, as some of you know he had always wanted a police department he was very proud of the fire department, when my daughter's house was destroyed by the tornado the fire department was there and I am very grateful for them. My family has been in Thetford Township for 150 years and very involved with this community

Motion by Treasurer Ayotte, support by Supervisor Kerr, BE IT RESOLVED that the township board of the Township of Thetford will conduct a public hearing at the township hall at Thetford, Michigan on Wednesday, September 23, 2015 at 7:30 p.m. to consider the proposed special assessment roll prepared by the township assessor pursuant to the direction of the township board, concerning the Public Safety District

previously created. WHEREAS, the Public Safety Assessment District within which the cost of fire protection and police protection are proposed to be assessed and the estimated cost of providing fire protection and police protection within the special assessment district for the calendar year 2016 is approximately \$375,000. The amount of the special assessment is based upon the special benefit to real property from the nature and level of fire and police protection to be provided by the township. Roll Call 7-0 Motion Carried.

BRIEF PUBLIC COMMENTS;

Started at 7:56 p.m, Ended at 8:12 p.m with three comments

- 1): Was a trustee and when he was on the board he told them we, as a township, were running out of money and that we needed to cut costs. Mad about two public hearings in one night, looks like we are trying to pull a fast one, Police toys, no cost cutting and increasing government.
- 2): wanted to make sure she understood what exactly the two public hearings entailed, would like to see the vote from the board that night believes the residents who showed up that night deserve to know that night, if there is a building on a vacant land will they get the special assessment? They will use it just as much as I would. If we would go to an election we can try to join another election to keep cost down. Mil vs a special election comments on that. Without an agreement on October 1st we would lose the fire department

Supervisor Kerr said according to our agreement we would have to give the Clio Area Fire Authority one year's notice. So yes, I would send them a notice

Within that year if we had come up with a plan can we tell the Clio Fire Authority we changed our mind and want to stay in?

So if we get the special assessment how much more would Chief Kenny get for his department? Answer: \$75,000

What does he plan on doing with that money? Answer: hiring a clerk and another full time officer

We have been taking these services out of our general fund, we have depleted it from roads and other things we needed.

3): likes the idea of two meetings in one day because sometimes it's hard to get the residents out for two meetings, just wants to know why on a Wednesday not a Monday? When he tells people the meeting has been changed they think you, as a board, are pulling a fast one on the people. Answer: The Monday and Tuesday of the week of September 21st Treasurer's department has other duties.

Would like to see the cost of a special assessment go on the ballot in 2016 as a millage for long term funding not an assessment.
