### **Brief Public Comments**

Public comments began at 7:16 p.m Ended at 7:21 p.m. Two comments were received

 If you would look on your front cover of the board packet on number #3 it says "At open board meetings, it is inappropriate to make personal attacks against township personnel, citizens and board members. If the comments do

constitute a legitimate complaint against an employee or a board member, the speaker is urged to present the complaint to the supervisor prior to requesting board consideration." You are a very professional board and handling yourself very well and it's not easy. You have one board member that really upset me, by his continued unprofessional conduct. There was a court case, which he started, he lost, it was decided and it was finished. Everyone has the right to appeal that is their right if they have the means for an appeal and an attorney to file the appeal then the appeal is filed. What that individual is asking this board to settle it, but the courts have settled it and this individual was awarded Zero dollars. If anyone of you as a board member use tax payer money to give him money to settle his case after the court has settled it, I will personally begin a recall against any board member that would vote to give him money. That is out of your jurisdiction, you cannot do that. Also please do not think it is ok for this trustee to stand here and say things like Judge Rosen is blind and corrupt, I am sorry Judge Rosen is a highly respected judge. Talking about Mr. Swartwood he served us well for eight years some people liked him and some didn't. That is irrelevant and this trustee is out of order with his comment. You have a wonderful Clerk who knows her job and does it well. If this trustee is so upset he is to do what is required of every other board member and resident make an appointment and discuss it privately with Supervisor Stevens.

• I have given you a board packet that has the facts to my case, along testimony, and along with a lot of other information you need to look at. You need to look at the whole scope of this issue. I have done everything I could with the previous administration that was in this township to resolve this issue. I am going to quote Bob with his letter of resignation that he gave to the township "getting their feelings hurt and wanting justice. I see it every day. The courthouse is the worst place to resolve differences..." that's a quote from our own attorney. I see you all are stonewalled right now and that's ok, I will only put up with that for so long but the facts of this case and the facts will speak for themselves. Bob Swartwood says some folks just want to waste their money and yours. That's what I am here to do, to protect this township on wasting money. This township has already spent \$65,000 on defending a boggiest warrant, a warrant that you can clearly see in the packet. I know its unpleasant thing to do, I know it's an unpleasant thing to face, especially for new board members. It's not going away and I am not going away.
