1. Verde Buena, 9030 N Saginaw, Suite #4, Mt. Morris – Site Plan Review for a Provisioning Center at the same address.

Fromwiller stated that they do have all the information needed and that they did a good job putting it together.

He also stated that it was noticed that the Zoning was RU-2 and not commercial. The property is classified as commercial, but not zoned. He also stated that he did not see a problem with the property being rezoned as it is in a commercial area. But, they will have to go to Planning for a re-zone request which

then goes to the Township Board for their first reading of the Ordinance and then for a final reading at the next meeting.

Fromwiller asked how long it will take them to get this property into shape and Mr. Meeks stated that Phase 1 will be completed within 4 months. He also stated that the permits will be pulled within 30 days with the landscaping done in the Spring.
